Each horse will be assessed a one-time/show office fee of \$20, per show.

Year-end awards for Champion and Reserve Champion will be based on number of eligible horses after 4 shows. Minimum of 3 horses in 75% or more shows for Champion buckle.

Minimum of 5 horses in 75% or more shows for Reserve Champion buckle.
